Decision under sections 19(1)(a), 20(1)(a), 20(1)(b), 46(1) and 46(4)

Decision on the obligation of digital service providers to register in the register of the Digital Security Authority.

89(I)/2020.

In exercise of the powers vested in it by sections 19(1)(a), 20(1)(b), 46(1) and 46(4) of the Security of Networks and Information Systems Law,2020, the Digital Security Authority (hereinafter "the Authority"), issues the following Decision.

Preamble.

The Authority having regard to:

89(I)/2020.

- 1. The provisions of the Security of Networks and Information Systems Law (hereinafter the Law) and in particular sections 19(1)(a), 20(1)(a), 20(1)(b)), 46(1) and 46(4) of the Law,
- 2. Directive (EU) 2016/1148 of the European Parliament and of the Council of July 6, 2016, and
- 3. The Commission Implementing Regulation (EU) 2018/151 of 30 January 2018,

issues this Decision determining the procedure for submitting an application for the purposes of registration in the register of digital service providers.

#### PART I INTRODUCTORY PROVISIONS

Short title.

**1.**This Decision may be cited as the Security of Networks and Information Systems (Registration of Digital Service Providers) Decision,2020.

Interpretation.

2.-(1) In this Decision, unless the context otherwise requires—

"Authority" means the Digital Security Authority;

"register" means the register maintained by the competent authority for the purpose of registration of digital service providers; "Law" means the Security of Networks and Information Systems Law, 2020 and includes any Law amending or substituted for the same.

(2) Any other terms which are used in this Decision and which are not otherwise defined shall have the meaning assigned to them by the Security of Networks and Information Systems Law, 2020.

Scope of application.

**3.**This Decision shall apply to all digital service providers.

# PART II PROCEDURE OF REGISTRATION OF DIGITAL SERVICE PROVIDERS

Registration of digital service providers.

- **4.-**(1) Every provider of digital services must register in the register that is kept by the Authority for the purpose of monitoring the systematic approach to information security.
  - (2) Following their relevant application in the form specified in the Annex to this Decision, all citizens digital service providers and all legal entities digital service providers who reside or have their corporate base in the Republic of Cyprus shall be registered in the register.
  - (3) (a) Natural persons must submit electronically the following:
    - (i) A certificate of clean criminal record that is issued by the Cyprus Police and its date of issue must not exceed six (6) months from the date of submission of the application for registration.

Provided that where the natural person is a resident of another member state of the European Union, the above document as well as any other documents requested by the Authority, should be obtained from the respective competent authorities and should be translated into the Greek or English language and shall be duly certified.

(b) The legal entities shall submit electronically the following:

- A report certified by the Director / Partner of the company / partnership which covers all managing persons who act on behalf of the company / partnership
- (ii) In the case of a company/partnership based in the Republic of Cyprus, the application shall be accompanied by the following information:
  - Memorandum and articles of association of the company/partnership
  - · certificate of incorporation
  - · certificate of registered office
  - certificate of directors and secretaries duly certified by the Registrar of Companies and Official Receiver of the Republic of Cyprus.
- (iii) For the Director / Partner of the company / partnership or other persons acting on behalf of the company / partnership, a clean criminal record with a date of issue no longer than six (6) months from the date of submission of the application for registration.
- (iv) In the case of a company/partnership registered in another member state of the European Union, the above documents must be obtained from the respective competent authorities and should be translated into Greek or English and must be duly certified.
- (4) The Authority reserves the right to request additional certified copies of documents concerning each natural person and each company / partnership.
- (5) Each application shall be examined by the Authority as soon as possible and the applicant shall be informed whether he/she/it was approved for the purpose of registration.
